5. CDOT Aeronautics **Internship Grant** & Master Plan

Grant

The grant agreements are for a 12-month internship program and for the FAA 5% match on the planned \$333,000 Airport Master Plan project. The grant for the internship program is \$16,640 and pays for up to 50% of the hourly wage for a paid intern employee. The grant for the Airport Master Plan is for a total of \$16,666 and will pay a 5% match on the 90% FAA

funding of \$300,000.

6. Strategic Plan Workshop Discussion

7. Centre Point Business Park TTF Challenges

The Airport has a through the fence operation that allows property owners located in the adjacent Center Point Business Park access to the Airport. This agreement was created in 1982 as part of the original development of the business park in an effort to encourage aviation development and airport use. Legal staff provided a confidential memo in January to the Airport Commission providing an overview and opinion of the existing agreement between the business park property owners and the Cities. The purpose of this item is to bring this back to the attention of the Commission and determine desired next steps.
